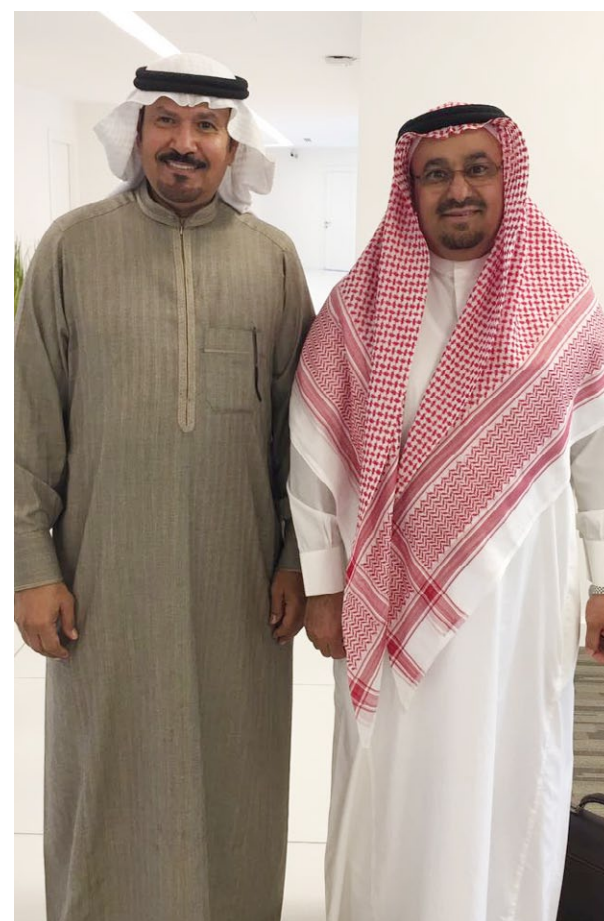

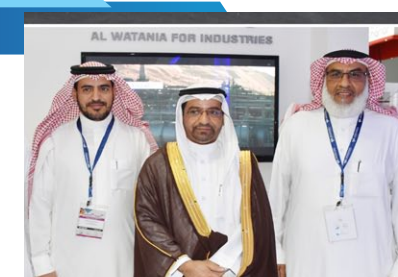

How do you see the year 2018 for Al Watania Paper Products in light of the economic recession in the region?

There is no doubt that the markets in the region are undergoing a process of correcting and restructuring, both for correcting the situation with respect to work and labor regulations, and the application of new services tariff and value added system, all of which will benefit in improving markets performance and thus raise the quality of the product and make local industries compete with imports. It is natural that these changes are all, of course, leading to this kind of economic recession. Therefore, Al Watania Paper Products management, under the guidance of the Board of Directors and the support and follow-up of the Chief Executive Officer, is working to implement effective plans for the continuation of expansion and focus on new products and quality, as well as reducing costs and expediting response to the demands of customers and access to new markets and customers. This leads to reducing the impact of recession, and leads to adaptation to this stage to ensure the achievement of budget plans for 2018, Allah willing.

What about the future of the carton industry in the Kingdom? What are the key trends in the industry?

How can Al Watania Paper Products exploit them?

In the medium and long term, carton products of all kinds are indispensable for packaging industry. Moreover, «the carton industry in the Kingdom» is considered to have reached a stage of high maturity; therefore, it has been given a competitive area both locally and abroad. One of the most prominent trends in this industry is its entry into the stage of manufacturing carton with high quality and accurate printing, using advanced equipment. This moves the product from being only used for packaging to being used as an advanced advertising interface for marketing and spreading the products of companies and distributors at the same time. Another trend is conducting advanced research to develop the raw materials used and assist in the development of industry. Al Watania Paper Products Company is a pioneer in this field, whether in implementing new technologies in the new Paper Products Factory in Jeddah, or in its direction to strategic partnerships in the field of industry development.

Do you have a strategy and vision for Al Watania Paper Products similar to the Growth Strategy 2023 for the Group?

As you know, we are one of the strategic business



units in the Group. We have a plan approved by the Board to achieve the 2023 Growth Strategy in terms of expansion and diversification of products and markets to reach a growth rate of 50%, which undoubtedly requires a double and integrated effort of the work teams and other units in the Group.

What are the expansion projects that Al Watania Paper Products is working on?

Several projects are being studied by the Strategic Planning of business development cooperation with the Evaluation and Investment Committee, whether acquisitions or partnerships in the market which are highly profitable. Other projects have been recently completed such as running the Paper Products Factory in Jeddah, which is a quantum leap in the paper products industry and is classified as the largest plant of its kind in the Middle East under one roof. The implementation of the technical amendment necessary for

the production line of egg cartons is another project, which will add high energy production to provide the local and the Gulf market with its requirements of these materials.

What projects have been completed during the last period?

As mentioned above, the last achievement of the Group was the inauguration of the Paper Products Factory in Jeddah, with the presence and generous patronage of the Chairman of the Board, Sheikh Sulaiman Al- Rajhi, the members of the Board of Directors and the Director General of MODON. It is classified as the largest plant in the Middle East in terms of energy production at one location, and also includes the latest technology and modern equipment in this industry. From January 15th to May 25th 2017, three levels of training has conducted to WFI employees in IMS. Sixty Two (62) employees were trained with essentials courses. Sixty Six (66) employees got qualified as Internal Auditors and thirty (30) employees achieved Lead Auditors Certification in all three systems from IRCA Approved Certificate. Preparation is underway to get certified to WFI in all Three System by the first Quarter in 2018.

- Marketing & Sales Committee charter.

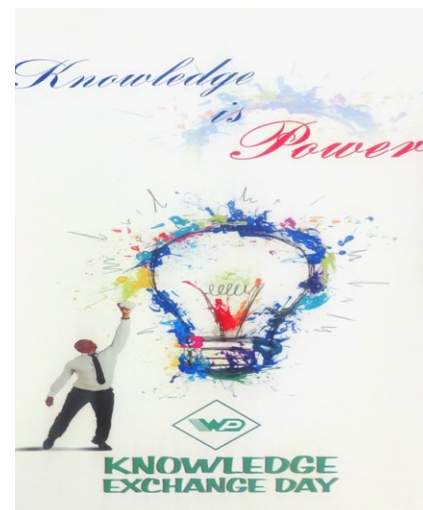
The Committee discussed main challenges and difficulties in marketing & sales in order to provide suggestions and find appropriate solution for them.

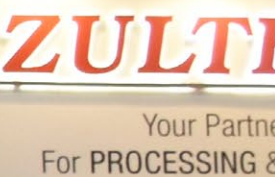
WFI Participated in Interbuild Jordan

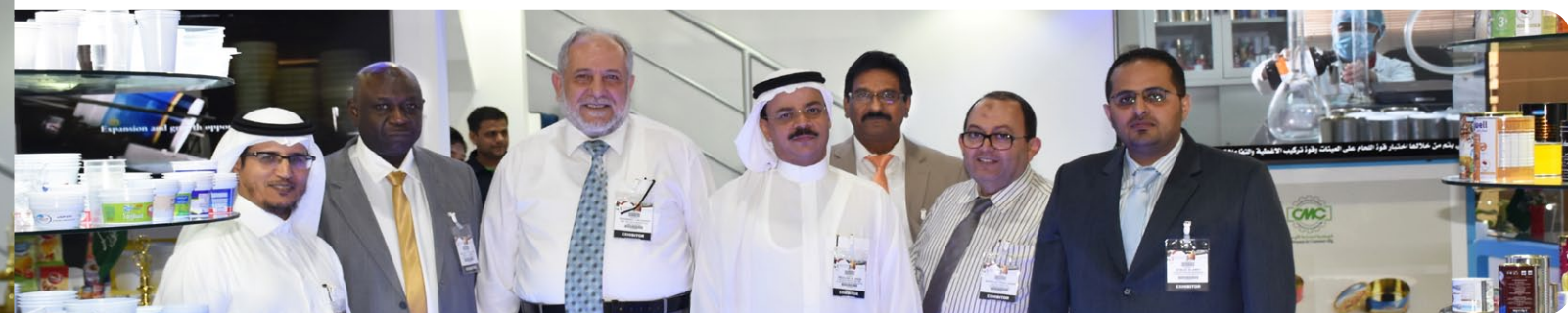
WFI in Gulfood Manufacturing Exhibition

At WFI & Its SBUs, the QSHE-MS implementation program has practiced in three levels. The First level of QSHE-MS is Quality, Safety, Health and Environment culture implementation at WFI and its SBUs. The Second level of QSHE-MS is compliance obligations pertaining to the National and International Regulatory Requirements and the Third level is evaluation of the QSHE-MS by the internationally recognized Certification organization for customer satisfaction. The implementation of QSHE-MS culture has progressed at WFI and its SBUs by the Corporate EHS Department synchronized with dedicated SBU's SHE Implementation Teams. During 2017,

the QSHE-MS culture implementation at WFI and its SBUs, around 2,334 SHE Inspections, 613 SHE Meeting, 526 SHE Awareness & Trainings and 20 Emergency Evacuation Drills has conducted at WFI and Its SBUs. Were by "11 Million Cumulative Safe Man-hours" has achieved and reduction in Occupational Injuries & Incidents to 8 compared with 18 Injuries & Incidents during 2016. The WFI's Senior Management Team (SMT) has been supporting by periodic review, recommendations, assistance and approvals for the QSHEMS culture implementation.

During 2017, entire Industrial activities such as Manufacturing / Production-process, Raw material & finished goods handling and customer care activities, WFI and its SBUs has Maintains total compliance with the SHE rules and regulatory requirements set by Saudi Arabian's Regulatory Institutions such as MODON, the Civil Defense, General Authority for Meteorology and Environmental Protection (GAMEP) and other applicable regulatory organizations. With these efforts, all SBUs have been awarded with Environmental Compli-



ance Certificates from GAMEP and also the Insurance Policy Percentage has maintained to minimum by GOSI. Interview with Engr. Abdullah Al Shamrani the industrial sector has the capacity to absorb a great deal of available re- sources and human resources

Al Watania for Industries is proud of its distinguished competencies working in all its various fields and administrative levels. The Company provides its staff with a stimulating work environment, many advantages, facilities, training and development opportunities. In order to get a closer look at the work environment, we held a meeting with one of the Company's employees Engr. Abdullah Al-Shamrani, Manager of Business Planning and Logistics at Al Watania for Containers Manufacturing. To the dialog..

First, please introduce yourself position and responsibilities?

Abdullah Mohammed Al-Shamrani
Manager of Business Planning and Logistics at Al Watania for Containers Manufacturing in Riyadh.
I manage planning tasks and demand management. My job includes receiving sales forecasts, creating a short and long term planning scenario, supervising the execution of the planning of raw materials and auxiliary materials, and planning production operations. I am also responsible for the management of logistics services, i.e. starting from receipt of finished products and storage methods to transfer and distribution operations.

How long have you been working in Al Watania for Industries? How do you evaluate the work environment in the Al Watania for Industries?

I spent more than 6 years in Al Watania for Industries. I have found a healthy, positive and enjoyable work environment, full of respect, cooperation and teamwork.



What distinguishes work in the industrial sector from other sectors?

The work in the industrial sector is different in many respects. On the economic side, the degree and development of any country is measured by the extent of its development in the industrial field. Thus, many countries have endeavored to transform their economies into industrial ones so that they pursue the developed industrial states. Socially, it is a sector with the capacity to absorb a great deal of available resources and manpower. At the individual level, any ambitious, productive, and committed person with the necessary skills will have the opportunity to grow and develop in a short period of time while ensuring development and continuity.

What are the skills that Al Watania for Industries has contributed to your development?
